INTERNSHIPS AT THE DANISH EMBASSY AND INNOVATION CENTRE IN ISRAEL

The Danish Embassy in Israel together with Innovation Centre Denmark, Tel Aviv is a dynamic place to work, located in one of the world's political and entrepreneurial hot spots. We represent Danish interests in Israel, covering public diplomacy, political affairs, innovation research, as well as consular and cultural affairs.

Now you have a unique chance to be a part of our great team in Israel. We are looking for three interns for the period, **February 1, 2022, to July 31, 2022**. Each intern will – depending on qualifications and interests – operate within the space of public diplomacy, communication, politics, innovation, diplomacy and trade.

Examples of tasks:

- Follow Israeli domestic and foreign policy
- Assist with organising digital events and possible visits by Danish delegations to Israel
- Assist with social media and web communication, co-develop and execute the Embassy's public diplomacy activities and other IT-matters
- Conduct research and prepare reports on innovation, entrepreneurship, research and innovation policies as well as political affairs
- Work closely with the rest of the team on project development and project planning
- Prepare/attend meetings and write minutes

Qualifications:

As an intern, you should have a bachelor's degree and be a master's student at a relevant higher education institution. Furthermore, you should have:

- Good analytical and writing skills

- Excel in English and Danish both written and orally
- Knowledge of politics, both from an international and a domestic perspective
- A natural ability to be a great team player
- Have knowledge of how innovation and communication are best supported by public and private players
- A keen interest in becoming an expert on building innovation eco-systems
- Strong networking skills

In addition, good insight into Israeli society and Danish/Israeli relations is obviously an advantage. Most importantly however, you need to be curious, flexible and eager to learn more.

TERMS AND CONDITIONS

The internships are open to both Danish and foreign citizens. It is required that foreign nationals have lived in Denmark for a minimum of 3 years, are residing in Denmark at the time of the application and are enrolled at a higher education institution in Denmark. The internship is conditioned on a security clearance by The Ministry of Foreign Affairs of Denmark.

The internships at the Embassy are of six months duration, approx. 37 hours weekly, **starting February 1, 2022**. The term of employment follows the guidelines set by the Ministry of Foreign Affairs of Denmark for interns.

Interns do not receive any salary during their stay and bear the costs associated with travelling to and from Israel, as well as their stay in Israel. The Embassy provides a monthly allowance for each intern to cover expenses up to 4000 DKK.

The deadline for receiving applications for the spring semester 2022 is September 13, 2021.
